Bodies of Work: A Network of Disability Art and Culture supports the development of new work that illuminates the disability experience in new and unexpected ways. I direct the program out of UIC's Department of Disability and Human Development with my graduate student advisees and community partners. We produce or co-produce up to 30 events per year including Chicago's Bodies of Work Festival of Disability Art and Culture. The 2013 festival featured local, national, and international disabled artists. We collaborate with Access Living, Chicago's renowned Center for Independent Living, on an annual series that includes a disability culture cabaret (Out Takes), concert dance (Counter Balance), and music (Dance to the Music). Events have included artists across mediums and have been presented in arts organizations, community centers, and universities. Since 2014, we have focused our efforts on events for the 3Arts Resident Fellows (in next section). We advocate for disabled arts, work toward an accessible infrastructure, hold workshops and master classes, and provide curatorial advice and technical assistance.

Direction includes choosing the artists, collaborating with the artists on conceiving their projects, preparing engagements with students and community, and program management (financial recordkeeping, co-producing all events, mentoring the artists, organizing staff and volunteers, maintaining communication with 3Arts, information dissemination, and coordinating disability accommodations). I also connect these artists with Chicago cultural institutions and artistic mentors.
