TEACHING PHILOSOPHY

INTRODUCTORY STATEMENT OF TEACHING AND LECTURING METHODS

The purposes of my lectures and writing workshops are:

- To promote a nuanced, intersectional disability narrative that pushes back on ableist or more mainstream narratives,
- To share insights on my journey as a research-artist-activist in the disability community through storytelling and art
- To infuse all of what you do with accessibility in creating your disability and selfadvocacy narrative, and an emphasis on letting people come as they are plus an emphasis on connection and openness, and
- To plan for creative and inclusive careers that utilize the combination of your advocacy, dreams, access needs, interests

In my writing and blogging workshops, I create opportunities and spaces for people with disabilities (including self-advocates) and English/Creative Writing/Disability Studies/ThinkCollege students to express themselves and share their stories through writing poems, creative nonfiction, blogs, and treatments for movies and TV/streaming shows.

As an artist with many disabilities, I find the power of art and writing to be freeing; I use my creative skills to broadcast my thoughts and feelings, and to contribute to a larger, vast narrative of being disabled (and in my case, with multiple intersectional identities like being BIPOC, non-monogamous, genderqueer cismale, etc.).

In my writing and blogging workshops, I create opportunities and spaces for people with disabilities (including self-advocates) and English/Creative Writing/Disability Studies/ThinkCollege students to express themselves and share their stories through writing poems, creative nonfiction, blogs, and treatments for movies and TV/streaming shows.

As an artist with many disabilities, I find the power of art and writing to be freeing; I use my creative skills to broadcast my thoughts and feelings, and to contribute to a larger, vast narrative of being disabled (and in my case, with multiple intersectional identities like being BIPOC, non-monogamous, genderqueer cis-male, etc.).

I enjoy seeing my students not only master various creative writing mediums, but also use those mediums to tell their story in a way that is FOR them and ACCESSIBLE TO them.

I don't subject my students to only one medium or one way of doing things. Writers usually come from many different backgrounds and have different viewpoints that they would like to address.

As such, I seek to create an environment where students, especially those who are already self-advocates, can explore options in crafting their own disability narratives, get the tools needed to create their stories, and bring prior experiences to the table while also expose themselves to concepts and artists with disabilities than can help enhance their artform and advocacy.

By the end of the workshops, students will produce a story where they can talk about their disability experience or tie their disability experience to daily life, things they enjoy, social topics, and more.

The story can be in the form of a poem, treatment for a movie or show, monologue, creative nonfiction piece (such as memoirs, essays), or a blog post.

There will be a few times where we can do check-ins on editing and progress on the final product.

And the cool thing is that students can turn it in either in written form, audio file, or as a video.

I don't turn down ways that students can turn in assignments, for some may either feel more comfortable with a particular way to write down thoughts or need to use a particular mode of writing for accessibility purposes.

While I do look for basic grammar structures, grammar will not be my priority when I assess your story. "Proper grammar" sounds ableist and elitist, and some of the best movies, songs, and written material I've enjoyed don't have "proper English".

I embrace students who are not afraid to incorporate their language, dialects, and personality into their pieces. I care more about your progress in developing your story, the authenticity of your piece (how personable is your piece), and if it fits or exceeds the expectations of the prompt that I give.

The main tenet of my lectures is to provide insight and shared lived experiences that students and audience members can take away and apply to their careers or life.

I do not assess how people use what they learned from my lectures; my goal is to share my story and expertise. It is up to you to decide how you can use lessons and tools from my lectures and speaking engagements.

The topics in any lecture or speaking engagement that I would be honored to cover are as follows:

- Intersections of race and disability, including Blackness, autism, and mental health
- Self-Advocacy, Disability Pride and Inclusion in Communities of Color
- Sexuality and Disability, including non-monogamy
- Disability Media Representation
- Inclusion in Sports, Arts, and Entertainment
- Inclusion in Full-Time Employment in Academia/Research
- Using Social Media And Art to Tell Stories in the Disability Community

While I spend a considerable amount of time telling my story, I prefer creating environments in which people can have a conversation with me or ask me any questions about what I talk about...or about me in general.

I would like for anyone to attend my lectures to leave with not only more information about myself or the topics I cover, but also feel connected with me through knowledge sharing.

Another way I like to connect with people is that I may use anecdotes or humor to connect people to the lecture topic.

I avoid as much jargon as I possibly can, and if I do use terms from the disability community or the fields I'm in, I would explain them first. I like to provide plain language materials in which many people can understand what I'm talking about, no matter who you are.

I am a firm believer in making the information accessible to as many people as possible.




